Complete the registration page with your name, address, phone number, and email address and click "submit" button and you will automatically receive one (1) entry. The registration page must be completely filled out to constitute an eligible entry. Use of any automated entry software is prohibited

##### **B. Mail-in Entry.**

Print your name, mailing address (no P.O.
